

OFFICIAL RULES

Susan G. Komen® Amazon Prime Membership Sweepstakes

Susan G. Komen would like to provide individuals currently undergoing breast cancer treatment a chance to win a one-year Amazon Prime membership.

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older and currently undergoing breast cancer treatment. Employees of Susan G. Komen ("Sponsor"), are not eligible to enter or win. There will be no requirements or requests on behalf of Sponsor to verify and/or submit any health information. All entries should be submitted in good faith.

HOW TO ENTER: Sweepstakes period is January 6, 2020 through January 31, 2020 at 11:59 pm CT. Complete the online entry form by accessing the provided link during the sweepstakes period. By providing your name, email, and mailing address, you agree to allow Sponsor to contact you about breast cancer news, inspirational stories, updates on how to get involved, and more. Entries must be complete to be eligible. For alternative means of entry, mail a 3 in. by 5 in. notecard to Sponsor's address, including full name, mailing address, and valid email address by January 15, 2020.

To double your entry, follow us on Instagram ([susangkomen](https://www.instagram.com/susangkomen)) during the sweepstakes period and enter your Instagram handle on the entry form.

Limit of one online form entry or alternative entry per person and one Instagram entry throughout the sweepstakes period. Additional entries will not be eligible to enter.

PRIZE DESCRIPTION: Each winner will receive a one-year Amazon Prime membership, valid from March 1, 2020 through March 31, 2021.

WINNER SELECTION: All eligible entries submitted during the sweepstakes period will be entered into a drawing on February 1, 2020. Winner(s) will be randomly drawn. Number of prizes depend on number of donations for this sweepstakes through January 6, 2020. Odds of winning depend on the number of eligible entries received for the sweepstakes and number of prizes donated.

WINNER NOTIFICATION: Winners will be contacted at the entry email address used to enter the sweepstakes. To claim the prize, winners must follow the instructions provided in the notification email and respond within 30 days. After the winner claims the prize, Sponsor will respond back with the prize redemption code. The prize redemption code will be needed to

redeem the prize on Amazon.com. Failure to timely respond will result in disqualification. It is within the discretion of Sponsor to select alternate winners if the prize is forfeited, but is not required to do so.
