

# **OFFICIAL RULES**

Susan G. Komen® National Breast Cancer Awareness Month 2021 Sweepstakes

**NO PURCHASE NECESSARY:** No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state, and local laws.

**ELIGIBILITY:** Sweepstakes is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

HOW TO ENTER: Sweepstakes Period is September 15 through October 31, 2021 at 11:59 pm CT. When you complete the entry form, you will be entered for a chance to win one of three prize packages. By completing the online entry form providing your name, and email, you agree to allow Sponsor to contact you about breast cancer news, inspirational stories, updates on how to get involved, and more. Entries must be complete to be eligible.
